

**LETTER OF AGREEMENT
between
ALASKA AIRLINES, INC.
and the
ASSOCIATION OF FLIGHT ATTENDANTS-CWA, AFL-CIO**

ADJUSTED TRIP TRADING DATES

This Letter of Agreement is made between Alaska Airlines, Inc. ("Company") and the Association of Flight Attendants-CWA, AFL-CIO ("Association").

In order to provide Flight Attendants the ability to trade with one another without having to compete for trip trading system server capacity at the same time as Open Time trading, the Association and the Company agree to adjust trip trading dates to the following schedule:
